Rebate Information

About this Program

This program was created to provide financial assistance to property owners making repairs to their sewer laterals. Rebates will be available to property owners for as long as the program funds are available.

Rebate Eligibility Requirements

In order to be eligible for a rebate through the City of Santa Cruz Sewer Lateral Incentive Program:

- The property must be located within the City of Santa Cruz
- The work must consist only of repair work to an existing lateral. Sewer lateral construction for new developments are not eligible for a refund.
- The work must be located in the Public Works jurisdiction, which is from the cleanout in the sidewalk to the City main in the street. Work on private property does not qualify.
- Only the four types of work listed on page 1, General Information, "Improvement:" are eligible for a refund.
- The permit for the work must have been issued on or after June 7, 2018.
- Application form must be submitted within 30 days of the completion of the repairs.
- All refund applications are subject to approval by Public Works officials.

Procedure

1. Applications are available at the front counter or online.
2. Applications must be filled out completely and submitted to the Public Works front counter within 30 days of the completion of the repair work. Forms can be hand delivered to the Public Works front counter, mailed to the Public Works Department, or emailed to dcabreross@cityofsantacruz.com.
3. Public Works will review the application and verify through their permit inspection program that the application accurately describes the work done in the field.
4. Once approved, the rebate request will be processed and a check will be mailed to the property owner as listed on the application form. Please allow up to 4 weeks for the rebate check to be issued.
