*P3a. Description: (Describe resource and its major elements, include design, material, condition, alterations, size, setting, and boundaries)

These two medical buildings, addressed as 536 and 540 Soquel Ave., are located across from Santa Cruz Hospital and were built prior to World War II. The Spanish Eclectic style architectural features of the medical office buildins were designed to correspond with the hospital that the owner had helped establish ten years prior to the construction of this building. The Eclectic Revival or Period Revival styles grew in prominence to become characteristic of both residential and nonresidential construction after World War I. Such styles as Spanish Eclectic, Mission Revival, Mediterranean, and others were popular for more than a decade. The stucco-clad Spanish Eclectic style corner office building at 540 Soquel Ave. steps downhill in form and includes such features as a red tile hipped and gabled roof, tile accents, and recessed entry, while the building at 540 Soquel Ave. includes

Dr. Norman Sullivan constructed the two medical buildings located across from Santa Cruz Hospital prior to the start of World War II. The Spanish Eclectic architectural features of the buildings located at the corner of Soquel and Ocean View Aves., were built by the contracting firm of Hamilton & Church and were designed to correspond with the Santa Cruz Hospital that Dr. Sullivan had helped to establish ten years prior. He shared the office building addressed as 540 Soquel Ave. with his new partner, Dr. Allegrini.

The second building on this property, addressed as 536 Soquel Ave. located to the west of the older structure, was built in 1940-1941 and originally housed Walter's Pharmacy. The proprietor of the pharmacy, Walter Bettencourt, later built the nearby Medical Arts Building to the west of his store. The storefront space is now utilized by a design firm.

SIGNIFICANCE

The property was not found eligible for the California Register of Historical Resources. The building is not individually significant to the development of the Eastside neighborhoods, and thus would not appear to be eligible under Criterion (1). The property is associated with Dr. Norman Sullivan, who is a well known person within the local medical community, but who is not recorded as important to the development of Santa Cruz. The property would therefore not appear to be eligible under Criterion (2). The building is a very good example of Spanish Eclectic design, but is not distinctive within the larger context of buildings done in this style during the Interwar years, and would not appear to qualify for the California Register under Criterion (3).

When considered for listing within the Historic Building Survey of the City of Santa Cruz however, the property meets the following criteria:

- 1. The buildings are a significant example of the built environment heritage of the City as a representative of a post-World War II era medical buildings; and
- 5. The buildings are recognized as possessing special aesthetic merit or value as a building with quality of architecture and that retains sufficient features showing its architectural significance; and
- 7. The buildings retain sufficient integrity to accurately convey their significance.

<u>Integrity</u>

The property maintains most of its apparent historical integrity as per the National Register's seven aspects of integrity. It maintains its original location on Soquel Avenue, an important commercial corridor east of downtown Santa Cruz. The property is still surrounded by much of its apparent historic setting, including surrounding commercial buildings of similar age, scale and design and parcels with similar setbacks, parking, and streetscape. It retains its midtwentieth century office building scale and feeling and continues, through their form, massing and detailing, to illustrate their associations with patterns of development in the twentieth century. The front façades retains their integrity with Spanish Eclectic design and workmanship, including the horizontal bands of windows and stone, along with the deep eaves and low-pitched roofs.
