Saturday, March 4, at 7:30am, 24 Beach Lifeguard/JG Instructor candidates lined-up and checked-in at Lifeguard Headquarters to try out for Beach Lifeguard/JG Instructor jobs this summer! By 8:00 am tryouts were underway off Cowell Beach. The physical test included a 1000 meter ocean swim within 20 minutes and 200 meter run/400 meter swim/200 meter run within 10 minutes. 17 out of 24 passed the physical test and moved on to interviews, the second phase of the hiring process. 12 of the 24 applicants were Captain Corps volunteers from last summer and they all passed the physical test and interviewed the following day!

The Police Department in collaboration with the Park Rangers completed a sweep of Highway 9 with a major clean-up operation of 20 illegal camps. The Downtown Ranger Unit has changed to a 10-hour work shift allowing increased coverage on Friday and Saturday.

## **PLANNING**

## **Short Term Vacation Rental (STVR) Process**

On March 7<sup>th</sup>, the STVR Subcommittee held their fifth meeting to discuss the framework for potential regulations for residential properties that are rented for less than 30 days at a time. There were about 50 members of the public in attendance. The Subcommittee reviewed a preliminary summary of the work to this point and determined that additional meetings would be desirable to more fully discuss some of the potential regulations relating to STVR's. Based on this additional time requested by the Subcommittee, the Planning Department will recommend that a City Council Public Hearing be scheduled for early May to extend the moratorium on new vacation rentals. The moratorium was slated to expire on May 31, 2017 and it is clear that no new ordinance will be adopted prior to that date. While all members of the Subcommittee, as well as staff, acknowledge the great amount of time that has been put into this issue up to this point, there was unanimous commitment from the Subcommittee to work through more of the details to make the potential regulations appropriate for the City. A recommendation for a new expiration date for the moratorium will be made after evaluating the progress of the next meeting.

#### Public Engagement Strategy Workshop in Sacramento

This week, three employees of the Advance Planning Division of the Planning Department attended a workshop relating to the challenges and opportunities for public engagement for City projects in the era of social media. The workshop was sponsored by the Institute for Local Government and related to the following topics:

- City-wide strategy for on-going public engagement as opposed to project or issue based outreach
- Budgeting time and staff resources for public engagement
- Changing the dynamic of public engagement from "3 minutes and a microphone" to a dialogue with the community

While the City already has a strong public engagement ethos for governing, we look forward to using new tools and methods to maintain and enhance community input and to engage with a broader cross section of the community in addition to those currently participating.

As a fun fact, our team took the train to Sacramento.



## 335 Golf Club Drive

This week, our department received an application to construct 10 residential units for the developmentally disabled on this 6.74 acre property below Pogonip Park. The parcel includes a residence that is included in Volume II of the City's Historic Building Survey. As part of the project, the applicants are rehabilitating the structure and taking advantage of an incentive we have in our Zoning Ordinance that allows variations to certain underlying development standards in exchange for rehabilitation of the historic building. In this case, the requested variation would allow attached units in a single-family residential zone. The project requires public hearings before both the Zoning Administrator and Historic Preservation Commission, which are expected to occur in the late spring/early summer timeframe. Ryan Bane will be the planner working on the application.

#### **SCPD Community Outreach**

SCPD continues with ongoing meetings to address the Latino community. In our community



outreach, we update, inform, listen and engage in conversations regarding the immigration enforcement by ICE. The meetings have been well received. The majorities of the participants are Spanish speakers and appreciate the coordination and explanations SCPD representatives have provided.

## **SCPD Safety Message This Week**

If you can't completely cross an intersection, don't enter it.

Raising driver safety awareness is a priority for the Santa Cruz Police Department. By implementing traffic enforcement initiatives, offering tips on sharing the road, and participating in regional programs, the SCPD is improving safety on the streets for walkers, bicyclists, and drivers.

The Santa Cruz Police Department traffic unit reminds drivers not to enter an intersection until you are sure you can make it all the way through. Wait behind the limit line, not in the crosswalk, and look to see if the vehicles in front of you on the other side of the intersection have left enough room for you to make it through without blocking or stopping in the crosswalk on the other side. This chronic problem will increase in the summer traffic, and our traffic guys do watch for this!

Blocking traffic in this way means that you have entered an intersection when cars on the other side are preventing you from making it all the way through. Per California Vehicle Code section 22526, this is illegal. If your signal light cycles to red before you can get completely through the intersection, you're blocking cross traffic from moving forward and preventing mobility in crosswalks and bike lanes. This makes an unsafe situation and commonly results in aggressive driving behaviors by other motorists.

#### **SCPD Community Education with Hope Services**

SCPD conducted a safety presentation for our friends with developmental disabilities at Hope Services. Many in the group have integrated jobs working in our community. Officer Deeg and

CSO Wilson taught them how to take care of situations that may come up with police, fire and medical emergencies.

## **Use of Force Training for SCPD Sworn Officers**

This week SCPD officers complete additional training with less lethal TASERs and arrest control techniques. Also, our officers are trained on the policies and procedures regarding the use of

force incidents.



Officers completed six scenarios which focused on armed confrontations, use of force situations where deadly force was not an option, subjects in mental health crisis or wanting to commit suicide by cop. The training focuses on tactical decision making, planning, and applications of the appropriate type of force to be used.

Officers have to make split-second decisions when it comes to using force while affecting an arrest.

Training in strategy and tactics,

control and verbal techniques, and proper use of force are essential to those decisions.



## **Streets**

Crews have repaired about 600 potholes as a result of our intense rains the past few months. This week included much work on Delaware Street.







## **Wastewater Collection/Flood Control**

Our crews have been playing catch up this week given a much needed break in the weather. The storm pump stations along the San Lorenzo River are getting a thorough cleaning of sand, silt and debris. Weed abatement is also in full swing with our Vac-Con crews tackling Zone 14 at Western Drive and Zone 15 on the Westside. Our construction crew is busy with sewer and storm line video inspections for storm related sinkholes and Capital Improvement Plan work.

## **Waste Reduction**

On March 8 a Santa Cruz Police Officer, two UCSC interns and 10 members of the PRIDE program tested their knowledge of proper recycling and waste sorting after our Waste Reduction Assistant led them on a tour of the Recycling Center on Dimeo Lane. PRIDE is the acronym for Personally Responsible Individual Development in Ethics, a program run by the City of Santa Cruz Police Department in conjunction with Santa Cruz City Schools. Officers mentor and guide local intermediate school aged kids through a multi-faceted approach to early gang prevention. Weekly outings and field trips provide the youth with an opportunity to engage and learn about the broader Santa Cruz Community.



## **Community Outreach**
