

# SCPD Dive Team Trains Search & Recovery Techniques & Tactics With City Wharf Maintenance Crew

Last week, SCPD ESU Dive Team participated in cross-agency training with the City Wharf Maintenance Crew. The water search and recovery drills on and off the Santa Cruz Wharf were part of a three-day exercise.

"Each year we train our officers with our partner agencies and all the equipment, specialized in water rescue training," said Lt. Christian LeMoss. Each search and recovery scenario is different, but choppy waters and strong currents are just



a few of the dangers of the job. Water search and rescues require knowledge about such things as the science of ocean,

proper gear, and lifesaving skills for victim's and the rescue team members.

This was one of several training sessions of Water Rescue's on the SCPD ESU Dive Team's training calendar. Every member of the SCPD Dive team and City Wharf crew passed with 100% competency. "At any given time, something could happen," said Lt. LeMoss. "We train hard, so we are prepared for anything."

#### **WATER**

Night work continues on the River Street main replacement project. Like the Cedar Street project, River Street is also fraught with decades of utility conduit placement, so we are anticipating surprises as we install new pipe. The water main will be installed at depths of 3'-7' on top of the existing water main in an effort to try to avoid the aforementioned surprises. The contractor has access to a drone, and provided us with some great photos of the project.



Work is going smoothly on the Newell Creek Dam inspection and condition assessment. We've been in close contact with the Division on the Dam Safety (DSOD) to keep them updated on our

progress on both the comprehensive condition assessment of the spillway as well as our updated Emergency Action Plan. In an effort to be proactive in our communications about the dam with the community, Rosemary went on Rosemary Chalmers live show on Monday and chatted with her about all the dam things. (Pun intended.)

Last weekend we celebrated National Lakes Appreciation Month at Loch Lomond by holding the annual Secchi Dip-In, which is an event to measure water clarity. We had a good turnout; many thanks to Mayor Chase for attending the event!



#### **PUBLIC WORKS**

#### Engineering

Lighting work continues on the Branciforte Creek Bike/Pedestrian Bridge and Multi-Use Trail
Project and will be energized at the end of next week. The trail is also scheduled to be paved by
the end of next week. The following week striping and signs will be installed marking substantial

completion of the project. Staff will discuss a formal and/or informal opening of the bridge and trail next week. The greatest challenge left on the project is deterring illegal activity and overnight camping underneath the new bridge, which is currently happening. Tight mesh fencing and stone placement is planned around the abutments of the bridge.







Fall 2016 Overlay Project work completed this week consisted of the adjustment of water valve boxes and sanitary sewer and storm drain manhole frames and covers at Mission Street Extension and Swanton Boulevard. Ocean Street is scheduled to be paved August 7- 9. Door hangers have been distributed to the residents within the limits of the project and a <u>press release</u> was distributed.



Ocean Street will receive Overlay installation next week.

#### Resource Recovery Facility and Processing

Landfill Operations received their new D7E bulldozer this week. Operator Training will be Thursday and Friday and we hope to start using it Monday.



#### **Wastewater Treatment Facility**

Employees in several divisions of the facility are required to maintain a minimum professional certification/license provided through either the California Water Environment Association or the State Water Resources Control Board. Not only is everyone working diligently to achieve the minimum requirements, many are continuing their education and upgrading their licenses. Amanda Bird has also been recently recognized by the non-profit CWEA, for her work on the local-section board of directors, in their Wastewater Professional magazine, Summer 2017 edition in an article titled "Emerging Leaders," (page 12,

#### <u>Laboratory & Environmental Compliance</u>

Environmental Compliance issued a Notice of Violation (NOV) with fine and charges for cost recovery to the owner/manager of a commercial property on Ocean Street last week. The NOV was issued because there was a sewer leak apparently connected to an unauthorized intrusion into a power control panel of the facility.

Public Works Engineering and Plant Maintenance are continuing this week to work with the Laboratory to commission the bioassay testing system and the integrative flow monitoring systems in the Bioassay Lab. Both testing systems are required for fulfilling our monitoring obligations under the NPDES permit program. In addition, the integrative flow monitoring system is used to assist Scotts Valley in fulfilling their NPDES monitoring obligations at cost for a sophisticated part of their obligations, including Dioxin and other trace organic compounds. Below our Environmental Microbiologist III and QA/QC Chemist review some of the installations inside the Bioassay Laboratory this week.



The Environmental Laboratory (WWTF) is cooperating with the Water Quality Laboratory (WQ Lab in the Water Department) in the latter's monitoring program for testing BOD and algal toxins in the source water at Loch Lomond. The WQ Lab needs to have three months of BOD (5-day and 20-day) analyses done from three sites over the three month period. The Environmental Laboratory will provide the analytical services in support of that project. In addition WQ Lab

manager will visit ourEnvironmental Laboratory with their newly hired Microbiologist next week to learn more about testing for algal toxins in surface waters. Personnel and Management from both laboratories look forward to working together to provide the greatest analytical support services to the community.

#### **Community Relations**

We have confirmed the location of our Pollution Prevention Award Dinner to be held on Sept. 21 at the Pasatiempo Room at the Back Nine Restaurant.

We have completed scheduling installation of Street Smarts banners at elementary and middle schools.

Placement will begin next week with the bulk installed the week of Aug. 14. We've received new display banners for our Street Smarts school assemblies and finalized long form traffic safety messages for Good Times and other media placements in English and Spanish.
