PLANNING AND COMMUNITY DEVELOPMENT

800 Soquel Avenue. Last week, an application was submitted to remodel the former *Der Wienerschnitzel* building at 800 Soquel Avenue and to create a take-out restaurant with outdoor seating and beer and wine service. The proposal is to maintain the general shape of the existing building while modernizing it with a new roof, exterior paint and materials, windows, kitchen, restrooms, and a cooler. The project would result in a 1,332 square foot building where an 802 square foot building currently exists. All seating associated with the restaurant would be outdoors and located toward the corner of Caledonia Street and Soquel Avenue. The applicants are also the owners of *Beer Thirty*, a popular pour house in Soquel with a similar site layout. It should be noted that the applicants have already secured approval for up to three food trucks on this site as part of the City's pilot program, which will be integral to this project. The site is located between a residential neighborhood and a developed commercial corridor; therefore, planning staff will be coordinating with Police and other departments to ensure that the proposed operations will not result in impacts to adjacent residences that are not normally associated with a commercial business.

The application requires Zoning Administrator approval of a Design Permit for the exterior improvements and an Administrative Use Permit for take-out/fast-food service, outdoor seating, and to allow for the establishment of a low-risk alcohol outlet. You might recall that last year a Design Permit was approved at this site to allow for the demolition of the existing building and the construction of a mixed use building with a first floor restaurant and two residential units above; however, the property owner has indicated that she had difficulty obtaining financing from lenders for the project. The vacant building has been an attractive nuisance for a number of years resulting in several complaints filed with our Code Enforcement Division. Development of this site is expected to go a long way toward improvement of this section of Soquel Avenue. Samantha Haschert is the planner working on this project.


SCPD Taking Action




Health Liaisons.

SCPD Sergeant Mike Medina Retires After 28 Years

Congratulations to Sergeant Mike Medina on his retirement after 28 years of service! The men and women at SCPD thank you for the many years of dedicated, reliable and resourceful service.

During Mike's tenure, he served in the Operations Division in the Patrol Section, Investigations Unit, and oversaw the Parks Unit. His duties included Field Training Officer, Investigations, Decoy Trainer for the K-9 Unit and a member of the Swat Team. He started the Bicycle Patrol Program on Pacific Avenue in the early 1990s. Medina was presented with the Medal of Valor for his actions during the 1989 earthquake, as well as presented with two Hazardous Duty Awards, and one Lifesaving Award. He became an SCPD Sergeant in 2010.

Sergeant Medina has been an outstanding example of loyalty and has been a tremendous asset to the City of Santa Cruz. His sense of humor will be missed by many inside and outside of the department.



PUBLIC WORKS

Streets

Streets crew has been working over the past two weeks to complete the repaving of Upper DeLaveaga Road with 150 tons of asphalt.









Operations

The annual San Lorenzo River flood control management program was completed on October 13. The contractor removed approximately 65 cubic yards of material from a 19.4-acre area. During the project, County of Santa Cruz Vector Control came out to address and mark yellow jacket nests, and expressed appreciation for the vegetation removal because it helps in the setup of mosquito traps and location of stagnant water that can be a source for mosquitoes. Park Rangers assisted the project by conducting sweeps of the areas and removal of trash prior to the contractor's crew cutting the vegetation.










The Corporation Yard Storm Water Pollution Prevention plan is in place, and training has been conducted with the assistance of Trinity Source Group. Departments and divisions that are located at the Corp Yard have storage space, or fuel vehicles are required to participate in the training.

<u>Transportation Engineering/Parking/Community Relations</u>

We have been awarded \$952,000 from the state for our Riverwalk Lighting Project which will install LED-pedestrian scale lighting between Water Street and Highway 1 on the east and west banks of the San Lorenzo River path. This funding is made possible by SB1: Road Repair and Accountability Act of 2017. The project is part of the Go Santa Cruz initiative. Read more.





We have replaced some of the downtown bike lockers which provide safe and secure bike parking for 5 cents per hour. From now on, all lockers, new and old, will accept BikeLink cards only—ParkCards will no longer be accepted. You can also trade in a ParkCard for a BikeLink card at the Parking Office.

Did you know that unsafe speed is the #1 cause of collisions here in Santa Cruz? Unsafe speed is not just exceeding the posted speed limit, but rather exceeding the safe speed for current roadway conditions. The <u>long version</u> of this week's Street Smarts traffic safety message below provides important information on this.



Students in our middle school Street Smarts after-school clubs have been conducting traffic assessments. The students will be presenting assemblies at all Santa Cruz City Schools elementary schools titled "Preventing Distractions in the Car and on the Road" in January, March and April. Wastewater Treatment Facility

Facility electricians, mechanics and operations were busy with numerous projects occurring simultaneously. Mechanics replaced a belt on a sludge feed pump from the Gravity Thickener with a smaller one that will be able to handle wet weather operations and an increase in sand during winter wet weather. Operations received a PIG (large rubber plug used to clean sewer pipes) from the County through their force main. Staff had to partially lower a gate to catch the PIG before it ran into equipment. Electricians repaired the parts washer and replaced a switch-gear on the secondary cogeneration unit. Operations and maintenance worked together to replace the sampler head on the County influent composite sampler, after it had malfunctioned. Mechanics also made a belt adjustment on the conveyor belt that carries removed screenings from the influent sewage flows to a hopper that is dumped twice a week and delivered to the landfill.



Resource Recovery Collections

We began food scrap collection this fall with a select group of grocery stores and restaurants that produce significant food scraps. Our goal is to help Santa Cruz businesses comply with the new law AB 1826 and keep food scraps out of the landfill. This week staff drove collected organics to the Mission Trails preprocessing facility. The food mash will then go to Sustainable Alternative Feed Enterprises (SAFE) in Santa Clara, to be made into animal feed.





Engineering

2017 Overlay Project work completed this week consisted of the demolition of existing non-ADA complaint curb ramps at the intersection of Escalona Drive and Laurent Street. We also removed non-ADA complaint curb ramps and installed ADA compliant curb ramps along King Street from Bay Street to Mission Street. This Measure H work will continue this Saturday, Oct. 21, on Escalona in order to finish the project before the rainy season commences.
