ECONOMIC DEVELOPMENT

1122 PACIFIC AVENUE REMODEL UPDATE

Staff has been working on remodeling 1122 Pacific Avenue and 1120 Pacific Avenue in the Del Mar Theatre building in order to combine the small spaces. Demolition and asbestos and lead removal have been completed. The next step is investigating the old plumbing for the construction of the new accessible restroom. In consultation with Fire, safety improvements in both the space being remodeled and the Del Mar Theatre are needed. Staff intends to perform all recommended safety work for fire prevention in the historic building. Funding is available in the Del Mar maintenance fund from Del Mar lease revenue. The work scope and schedule is being developed and we will update you soon.

All the cool kids will be at the Abbott Square grand opening tonight (9/1/17) with the official ribbon cutting at 7:30pm. While you are there, take a quick peek across the street to the signal box in front of the Galleria which now has a refreshed image of the Cooper House. The original Cooper House was a well-known in Downtown Santa Cruz. It was on postcards. It was once the courthouse of Santa Cruz. From the 1970's to the Loma Prieta Earthquake of 1989 it had a variety small shops and a restaurant and was popular with many locals. In 1973 it was awarded Landmark Status by the Santa Cruz Museum of Art & History and it was added to the Santa Cruz Historic Building Survey in 1979.



The Murals are multiplying! No, it's not the plot of a crazy sci-fi movie –three new murals will be done soon, thanks to the City's public art program and the City's <u>Mural Matching Grant program</u>.

SCOPE PARK MURAL ARTIST, SARAH BIANCO, SET TO "JUMP IN!" AND STARTING PAINTING SOON!

After a process to deaccession the prior mural, a public meeting on site with the artist to collect feedback, and a public hearing at an August Arts Commission meeting, artist Sarah Bianco's concept "Jump In!" was approved unanimously by the Arts Commission. Sarah presented a thoughtful view of inclusivity to the Commission – inspired by ideas of children and their openness and of dissolving boundaries. Her concept will feature local children that she will use as models, jumping in a variety of poses with the backdrop of the Santa Cruz coastline. It also features web of honeycomb shapes and dots and the phrase "Jump In!" One commenter noted that both *Moonlight Dance* and *Jump In!* joyfully feature people jumping near the Pacific Ocean. While the connection may be subtle, they both represent the joy of being with others.





Moonlight Dance, was installed at Scope Park by Peter Bartczak in 1993, who graciously gave his blessing for a new mural on site. A Farewell Party was held on July 15, 2017, celebrating the mural and his legacy. You can watch a video of the Farewell Party here.

DIVERSITY CENTER YOUTH MURAL "COLONIZE, UNIFY, THRIVE!" WILL BEGIN NEXT WEEK



Youth and staff from the Diversity Center, led by co-artists Manny Garcia and Oliver Whitcroft, will begin work on a new mural on the privacy wall at the Louden Nelson Community Center – at the corner of Laurel and Center streets across from the Police Department. The mural has already generated a lot of buzz and, with excitement, the City's Equal Opportunity Employment Committee is also working with Beth Tobey and staff from the Diversity Center on an optional brown bag lunch for City employees seeking to understand better the issues that LGBTQIA people face and how to support them. NEW MURAL AT MANDALA HOLISTIC HAIR AND WELLNESS – THANKS TO CITY'S MURAL MATCHING GRANT





The City first began placing murals in downtown alleys in 1994 in an effort to help businesses deal with graffiti and bring vibrancy and recognition to local businesses and historic landmarks. The program has shown that great things can happen when a motivated artist meets a motivated business owner! Starting soon, local artist Rachel Barnes will be painting a new mural on the wall shared between Mandala Holistic Hair and Wellness Studio and Los Pericos restaurant at the corner of Water St. and River. The mural will replace the other smaller mural painted there which the business owner decided, that she didn't like. (No public or City funds were given to the prior project – it was totally private.)

The approved composition consists of a profile of a blissful woman. Her hair extends to the left and morphs into a nature scene. The scene is composed of ocean and mountains. Within these

landscapes there are smaller sites specific to California's natural wonders. The purpose of the mural is to remind the viewers of the deep relationship between ourselves and the natural world that surrounds us.

PARKS AND RECREATION

Parks Master Plan 2030 Update

Following the joint City Council/Parks and Recreation Commission (Commission) Study Session on February 7, 2017, the Commission has met several times to provide opportunities for additional public input and discuss the following topics in the Draft Parks Master Plan 2030:

- West Cliff/East Cliff Linear Park
- San Lorenzo Park Recommendations
- Santa Cruz Riverwalk Recommendations
- Pickleball Facility Recommendations
- Considerations for Exploring Mountain Biking and Multi-Use Trail Opportunities in Pogonip Open Space and DeLaveaga Park
- Priority Action Clarification for 2030 PMP

Parks and Recreation Department staff and the project consultant Royston Hanamoto Alley and Abey (RHAA) are incorporating the feedback received from the Study Session and subsequent Commission meetings in preparation for a special Parks and Recreation Commission meeting on September 25, 2017. An updated version will be provided to the Commission on September 5, 2017 for their review. Parks and Recreation staff will offer to meet with each Commissioner individually to review the latest changes and answer any questions that may arise prior to September 25th.

Following the September 25th Commission meeting, staff anticipates that it will present the revised draft Parks Master Plan 2030 to City Council at the October 10, 2017 City Council meeting. Staff will be asking for conceptual approval of the Parks Master Plan and direction to begin the CEQA environmental review process. Similarly, staff will be available to meet with each Councilmember individually to describe the changes and answer any questions that arise. The CEQA process is expected to be completed in January/February 2017 at which time the project will return to the Parks and Recreation Commission and City Council for final review and approval.

Golf Fee Study

Staff IS issuing a purchase order to Pro Forma Advisors to conduct a fee study for Delaveaga Golf Course. Work will begin in approximately 3 weeks and will be completed approximately 2 weeks after commencement. Once completed, the data will be evaluated and the results will be presented to City Council.

Staff has completed the renovation of the Grant Park restrooms.

PUBLIC WORKS

Engineering

The Branciforte Creek Bike/Pedestrian Bridge and Multi-Use Trail Project opened up to the public on Friday, September 1. The soft opening marks substantial completion of the project. The public will now have the ability to walk/ride 5 continues miles around the river levee, car free! Official opening and ribbon cutting ceremony for the bridge and path is scheduled for September, 28 at noon. Staff will begin working on details in the coming weeks. Work still to be completed includes fencing, hydro seeding, lighting, irrigation, and trash/recycling receptacles.







Resource Recovery Waste Reduction

Staff attended the annual California Resource Recovery Association (CRRA) conference in San Diego. Highlights included the first CRRA/SWANA Zero Waste Principles & Practices Certification Program, a session on food waste, illegal dumping and tours of local facilities including SeaWorld and the San Diego Zoo. Staff came back with lots of information and new ideas.

Waste Reduction staff attended the first planning meeting for Earth Day 2018 which will take place on Saturday April 21. This annual environmental event is co-sponsored by the City and County of Santa Cruz and Ecology Action.



Wastewater Treatment Facility

Mechanics and electricians investigated an issue with the raw influent pumping that operators had noticed. They discovered a failed influent pump impeller with subsequent removal and replacement. Operations also conducted routine maintenance work on the ozone generating

units which are vital in managing the odors emanating from the sewage water. This work ensures continued optimal operation of the odor control system.

SCPD Conducts Minor Decoy Alcohol Sting

Last week Friday, August 25th, SCPD worked a minor decoy sting operation. The purpose of the sting operation was to ensure that businesses are not selling alcohol to underage customers. Under the direct supervision of the officers, minor decoys (juveniles under the legal age to drink/purchase alcohol) entered businesses that are licensed to sell alcohol and then attempted to purchase alcohol.

SCPD conducted minor decoy operations in a total of 18 businesses. The following five businesses had employees that sold alcohol to the minor decoys:

Safeway 117 Morrissey Blvd.

Walgreens 201 Front St.
Valero Corner Store 1319 Ocean St.
7-Eleven 602 Laurel St.
Hernandez Market 525 Laurel St.

The other 12 businesses asked for identification and declined to serve the decoys. . It is encouraging when the employees check identifications and refuse to sell alcohol to minors," said LT. Garcia

The businesses who sold alcohol to a minor will have administrative action taken against them. That action may include a fine, a suspension of their liquor license, or the permanent revocation from the Department of Alcoholic Beverage Control.

610 Frederick Street

This week our department received an application for a Design Permit from *Dignity Health* to demolish the 58,000 square foot three story *Dominican Rehabilitation Services* building and replace it with a 60,000 square foot two story medical complex. The property is "T"-shaped placing the development behind two office buildings that flank the driveway into the complex. The proposed project is in the Professional and Administrative Office Zone District where medical offices are principally permitted. As such, the Design Permit can be administratively approved by staff without a public hearing. Mike Ferry is the planner working on the project.

CLIMATE ACTION PROGRAM

With funding approved by City Council at the start of calendar year 2017, the Climate Action Program worked with Public Works, the Building Division of Planning, and 4 different property owners to design and install energy efficient lighting for the levee facing and parking lot sides of seven buildings on Front Street. The project entailed replacing existing fixtures, the addition of new fixtures, and all associated sensors and wiring to improve safety and conserve electricity. In total 27 existing fixtures were replaced and 16 new fixtures were installed. The project was

completed in early August, 2017. Attached are some images showing the new lighting. Building owners have already reported they have observed a decrease in illegal activity in the area as a result of the new lighting.
