# **Traffic Engineering/Community Relations**

On January 24 the Downtown Commission approved the proposed Downtown Employee **Transportation Demand Management (TDM)** program. The TDM program is a package of benefits and incentives that make it easier for downtown employees to choose not to drive to work, which in turn reduces congestion, maximizes our existing parking resources, and helps to meet our Climate Action Plan goals. The recommendations made were based on two Downtown Employee Commute Surveys where employees were asked what type of transportation they would like to use, what would encourage them to shift how they travel, and what barriers they have to switching away from driving. The results of the two surveys and a program recommendation are planned to come to Council in February, with program rollout shortly thereafter—all a part of our **Go Santa Cruz** initiative.



Our **JUMP** bike share system launched a new Boost membership option last week. The Boost plan costs \$5 per month for 60 minutes of ride time per day and is available to anyone enrolled in the PG&E Care or CalFresh programs. # **Engineering**

The San Lorenzo River Parkway Phase III/Trestle Trail Project continues this week with forming and placing concrete for abutment number 1 wall (next to the Boardwalk). The Trestle Bridge

will be closed for the duration of the construction project. The project, funded by City of Santa Cruz, Measure D and a California Natural Resources Agency Grant, is widening the existing San Lorenzo River trestle walkway and is expected to conclude before this summer.









The Cedar Street Rehabilitation Project is on hold this week due to weather. The project, funded by Measure H tax dollars and Community Development Block Grant (CDBG), will rehabilitate/reconstruct Cedar Street from Church to Laurel.
