STOREFRONT BEAUTIFICATION GRANTS, SUBMISSION WINDOW MARCH 1 - 31

The application period for a new round of grants for local business and property owners to help spruce up their storefronts and improve the appearance of the city's retail districts opens March 1.

In preparation of the opening of the application period Economic Development Coordinator Ali Cameron has been conducting outreach to targeted businesses with the help of Community Liaison Peter Bichier to connect with Spanish speaking businesses and those businesses that might not be aware of this program through our traditional marketing efforts. On Thursday, February 14th, Ali and Peter were able to meet with about 17 businesses to share information about the program and plan to hit the streets again to do more door to door marketing to broaden the reach of this program.

Information about the application period was also featured in the Sentinel's Business Digest on Friday, February 15th and a press release is posted on the City's website.

The Façade Improvement Grant Program provides eligible business and property owners with a full \$10,000 grant, plus a matching grant of up to \$5,000, for exterior painting, new awnings, signs, lighting, landscaping and refurbishing architectural features. The

Commercial Signage Program provides eligible business and property owners with a 50% reimbursement grant up to \$5,000 to enhance their storefronts with the addition or improvement of commercial signage.



Santa Cruz business and property owners located in commercial districts are eligible to apply to either program. Non-profits are also eligible if located within commercial corridors. Spanish translation is available for all grant applications and information.

The spring application window is open **March 1, 2019 and will close March 31, 2019**. Another round of applications will be accepted in the fall.

Interested applicants are encouraged to attend the city's pre-application orientation which will take place at 8:30 a.m. February 25 in the City of Santa Cruz Economic Development Office, 337 Locust Street. Please RSVP to Ali Cameron, acameron@cityofsantacruz.com or call (831) 420-5158.

OCEAN MURAL STARTING SOON ALONG MISSION STREET!

A grand-scale mural will soon begin along Mission Street through a collaboration of the City of Santa Cruz, Santa Cruz City Schools, Clean Ocean's International, the Tim Brauch Foundation and the [Fresh Walls Collective](#)--led by local artists [Taylor Reinhold](#) and [Scotty Greathouse](#).

Initially conceived by Jim “Homer” Holm, founder of [Clean Oceans International](#), and Taylor Reinhold—the City was contacted last year for permission to do a mural along that wall. Through a process of discovery, the City realized that the School District owned the wall. Bay View Elementary staff and the Superintendent’s Office were brought into the conversation and the Santa Cruz City School Board unanimously approved the project in February, 2018.

“The ‘Healthy Marine Environment’ mural celebrates Santa Cruz’s intimate connection with our precious ocean,” says Capt. Jim “Homer” Holm. “With a new mural, this wall along Mission Street could help to generate new dialogue and awareness around the health of our oceans, and Taylor’s crew has demonstrated their ability to grab the public’s attention through beautiful artwork.”

With approximately \$50,000 in hand, the mural will be started in April-May but the artists still need to raise another \$35,000 to complete the mural. The City of Santa Cruz has contributed \$20,000 through the City Arts [Mural Matching Grant](#) program. The School District is contributing approximately \$20,000 through in-kind funds already set aside for maintenance of the wall. The Newman Foundation has committed \$10,000 and the artists have raised several thousand through small fundraising efforts---BUT hoping that the Community will get behind this project and donate at their GO FUND ME PAGE here: www.GoFundMe.com/CleanOceansMural

City staff has assisted the artists in getting permits from CalTrans to close one southbound lane of Mission Street for a night (10pm-5am) so that the artists can trace their mural design.

2019 UCSC Housing Fair Report

On the afternoon of February 06, 2019, Santa Cruz City Code Compliance (Code) and Inspectors from the Residential Rental Inspection Services (RRIS) attended the annual UC-Santa Cruz Housing Fair. The fair brings together public and private housing-related agencies into one event on campus to provide resources for those students searching for off-campus housing. This year, campus organizers of the event documented over 500 attendees.

Code and RRIS Inspectors interacted with about 100 students during the event. We were able to distribute RRIS housing safety check-lists, explain how the City enforces the Housing and Building codes; gave them tips on the minimum housing safety standards, explained the City's Relocation Ordinance and referred students to non-profits that handle tenant-landlord issues/disputes.

With a generous donation from the City Fire Department, Prevention Office, we gave away several smoke alarms to students who completed our housing –safety survey.

Apart from the contact with students, we shared information with other agencies present, including property management companies and the UCSC Housing Office.
