City Manager's Weekly Update January 11, 2019

PARKS AND RECEATION

Wharf

Work has begun on the demolition of the Miramar. Some unexpected demolition occurred when a waterspout hit the Dolphin. The Wharf Crew assisted with emergency tarping until a more permanent repair could be completed.





Frederick Street Park

Following completion of the PG&E gas line project, hand seeding with native seed mix and top dressing of the sloped areas with new erosion control installed. The entirety of the dog park has been set to final grade, irrigation system upgrades and repairs performed. We are ready to go with hydroseeding of the dog park as soon as mother nature allows for a decent spell of dry weather.







Ocean View Park Pathway

Upgrades and preventative erosion control infrastructure is being installed along the Ocean View Park Pathway. This pathway is a busy conduit for The San Lorenzo River Walk and the Seabright Neighborhood. Retaining walls going in, drainage upgrades and split rail fencing going in to create a safe path of travel.





Arana Gulch

The cows are back in Arana Gulch for the season. These grazers keep the grasses low and help create conditions for germination of Santa Cruz tarplant.

Soil samples have also been taken from Arana Gulch and will be sent to a lab to analyze the nutrient levels. The results will hopefully lead to a better understanding of the optimal nutrient levels for the tarplant. Data from onsite tarplant areas will be compared to see if there are any similarities, as well as from non-tarplant areas to see if there are any differences. Additionally, the data will be compared to soil testing performed prior to the beginning of cattle grazing as a means to monitor how cattle grazing has affected the nutrient levels of the site. The City is taking the lead on what will hopefully become a broader study. The US Fish and Wildlife Service will be working with other landholders with Santa Cruz tarplant to perform similar analyses. If there is a specific nutrient mixture which benefits the Santa Cruz tarplant, the Parks and Recreation Department can then begin to experiment with soil amendments to improve the habitat.





PLANNING

314 Jessie Street

On December 18, 2018, MidPen Housing submitted an application for Pre-application Review of a 27-unit, 3-story, 100% affordable, residential development to create supportive rental housing on two parcels located at 314 Jessie Street. The property is currently developed with a permitted, 14-unit residential building that houses referral patients from the county mental health facility. The proposal includes demolition of the existing building; however, the tenants within the existing 14 units would continue to be housed at the site within the new building.

The proposal includes 16 studios which range between 367-378 sq. ft., and 10 1-bedroom units, which range between 599 and 691 square feet. The project also includes an additional 616 sq. ft., 1-bedroom managers unit as well as residential amenity space and office space for counseling and other tenant services. The Zoning Ordinance provides three levels of multiple residence zoning: R-L (Low Density); R-M (Medium Density); and R-H (High Density). The project is site is currently zoned as R-L and the proposed density at 73 dwelling units per acre would require a rezoning of the property from R-L to R-H as well as approval of a 35-percent density bonus. The proposal also includes a request for reduced open space requirements and reduced front and side yard setbacks as concessions/incentives.

While a more thorough review will be conducted as a part of the pre-application review process, it is estimated that the project would require a recommendation of approval by the Planning Commission and approval by the City Council of a Rezoning (R-L to R-H), a General Plan Amendment (LM to H), a Residential Demolition Authorization Permit, a Lot Line Adjustment to combine the two parcels, a Coastal Permit, a Design Permit, and a Slope Variance. As the site is in the Coastal Zone, changing the underlying Zoning and General Plan designation would also require approval by the California Coastal Commission.

According to Library Director Susan Nemitz, "Navigating legal and financial life events can be overwhelming. Getting a good overview and having a professional answer questions can significantly reduce this stress." Nemitz also indicated that the series is a result of a 2018 SCPL Innovation Grant. These small internal grants "...encouraged staff at all levels to look to their own passions, and to try something new to meet the needs of the community." The new series will serve as a pilot to help determine which additional topics and formats will benefit the community.

Free Self- Management Program Helps Those Living With Ongoing Health Conditions

Better Choices, Better Health is a 6 week self-management program series provided in partnership with <u>The Health Trust</u>. Workshops are led by trained community leaders and intended for anyone dealing with the challenges of living with chronic or ongoing health conditions such as diabetes, heart disease, asthma, or high cholesterol and/or their caretakers. Participants



will learn about stress management, dealing with pain & fatigue, weight management, decision making, and more.

According to the Santa Cruz County Health Services Agency, chronic health conditions are the leading cause of death in the US, and are also the most preventable. The Health Santa Cruz County 2015 Report indicates that in 2015, 24% of adults over the age of 20 had high blood pressure. According to Library Director Susan Nemitz, "SCPL connects people with critical information that can transform lives. This is an excellent partnership with the potential to help many in our community live longer and healthier." Workshops are fun, interactive, and designed to enhance regular treatment and condition-specific education.

Workshops are Monday's 10:30am to 12:30pm from January 28th, 2019 through March 11th, 2019, except for Presidents Day, at the Downtown Library Upstairs Meeting Room.


Engineering

Wastewater Treatment Facility

This week our WWTF weather station recorded a total of 1.99" of rainfall and peak wind gusts of 38 mph. When it rains in Santa Cruz the treatment facility feels the impacts more than other local locations as we sit below sea-level at one of the lowest spots in the City. Operators saw the influent flow peak at 47 million gallons while the normal daily flows average 8 million gallons. This increase in flows pushed material including rocks, rags and sand in the sanitary sewer collection system to the treatment facility. Staff worked to remove approximately 20,000

Resource Recovery

Last week our street sweepers collected 21.33 tons of debris from City streets.

Recycling processed 159.53 tons of mixed recycling, 37.32 tons of cardboard and shipped out 78.65 tons of material for the week.

Landfill Operations processed 786.01 tons of refuse, 170.01 tons of wood and green waste, and 127.12 tons of fill material for the week.

Pictured below is our new landfill compactor delivered to the Peterson facility in San Martin. A final walk through and installation of a fire suppression unit needs to be completed before final delivery to our facility on January 23rd. Training is scheduled for the afternoon of the 23rd and all day the 24th.





Waste Reduction staff just found out that the UPS stores are no longer accepting Styrofoam peanuts from the public to reuse in the package shipping operations. Speaking with the manager at the Soquel Ave. location we learned that this is a new UPS company-wide policy and not specific to the City of Santa Cruz. They have switched completely to the air pouch system (like Amazon). The decision was both from an environmental stand point and a safer way to ship things. They will still ship a customer's package if it is packed in packing peanuts, but will not use them in house. Unfortunately, that leaves residents with no option to recycle packing peanuts. We will be changing the information on our web pages to notify residents

that they should be contained in a bag and put in the trash. Block Styrofoam is still accepted at Grey Bears, but they do not accept peanuts or food packaging.

The current 2019 Refuse and Recycling newsletter was mailed to all single family households as well as duplex, triplex and 4-plex housing. The newsletter contains important information, a recycle guide and annual service tags that residents may use for bulky item pickup or extra trash or yard waste. At the same time Waste Reduction staff is reaching out to multi-family complexes with presentations to assist residents with their recycling questions. This is an important avenue from outreach to deliver current recycle guides and information to apartments complexes.



Waste Reduction's upcoming Master Recycler Volunteer Training Program will begin on Feb. 5 and run through March 19, with seven evening classes and two Saturday field trips. Students will learn about waste prevention, recycling processes, zero waste concepts, community engagement and much more. VIPs walk downtown, relieve cops of none essential tasks, educate on crime prevention and provide a visual deterrent. They are the best," said Chief Mills Santa Cruz Police could not be more pleased with each of them.

SCPD has engaged a team of trained citizen volunteers to support the department in non-enforcement duties. Our dedicated group of volunteers will help officers to provide additional services, maintain positive relationships with the public, free up officers' time for higher level duties, and maximize impact in the community.

"Each volunteer on the streets will increase both community safety and department effectiveness by adding more eyes and ears and by freeing up sworn police officers to complete other critical tasks," said Chief Mills. Together, we can help to ensure the City of Santa Cruz remains a safe place in which to live and work."



Uniformed police volunteers will be patrolling the downtown area and, neighborhoods. They observe and report crime and quality-of-life issues to the department staff. Santa Cruz Police Volunteers do not take enforcement action, carry weapons, or make arrests. Volunteer duties also include welfare checks on the elderly, conducting vacation home security checks, working at special events, enforcing parking violations, vehicle abatement and helping the department with clerical tasks.

Volunteers undergo screening and background checks, must be at least 18 years of age and be able to commit to a minimum of eight hours a month.
