

## Planning & Community Development

### 119 Coral Street (File No. CP20-0047, APN

**001-172-14).** On November 19, the City Planning Commission approved an application to construct a five-story, mixed-use project to provide services and 100% affordable supportive housing for the chronically homeless at the Homeless Services Center Campus at the corner of Highway 1 and River Street. The first floor will consist of a new recuperative care center, a behavioral health clinic, and uses related to the upper-floor residences. The upper four stories will consist of 120 supportive single room occupancy (SRO) units and one manager's unit. The units will be used as very-low-income supportive housing for those needing a high level of ongoing supportive services uniquely available at this location. The application approval included a Residential Demolition Authorization Permit, Design Permit, Special Use Permit, and a Density Bonus Request to exceed height. As part of the motion to approve the project, the Planning Commission added a condition that requires the applicant to provide a Services Plan, as well as a Property Management Plan. Also, the Commission recommended that the City Council support the fee waiver that the applicant has requested, with the caveat that the project be required to be 100% affordable at the very low-income level in perpetuity. The fee waiver request will be before the City Council at an upcoming meeting. Ryan Bane is the planner for the project.

### Parks Update

The San Lorenzo Benchlands Camp was closed last week, and City staff, along with contractors, did an excellent job cleaning and reseeding the benchlands area.



City Parks crews are hard at work at Harvey West Park removing the old Oak Picnic area to make way for a larger meadow. The large oak tree at the original picnic location fell last summer. A new Oak Picnic area will be created in a shaded area of the park.







## Resource Recovery

Waste Reduction staff's recent outreach efforts seem to have made a difference in reducing Thanksgiving post-holiday contamination in the recycling carts. Cart inspections revealed that mostly clean recyclable items were in the carts in areas previously noted to be problematic.

## Wastewater Treatment Facility

Demolition is nearing completion on the ultraviolet disinfection system upgrade project. Contractors have re-made the channels that will house the new UV light system, and the electrical control building floor has been dug out to accommodate the new system panels.



Operations performed an Effluent Pump Test. This is a monthly preventative maintenance task done to verify this emergency equipment will turn on when needed. The natural gas-powered engines and pumps turn on automatically during high flow situations to help push the treated effluent out to the gravity-fed ocean outfall pipe. To simulate high flows, Operators change the flow of the treated effluent waters to head back towards the flow entry point of the treatment process. In this test, we

were able to simulate incoming flows of 56-million gallons. The high flows generated during this test also help scour settled material from the pipes within the facility, which is removed through the pre-aeration grit removal system that, in turn, dumps the accumulated material into a hopper for later disposal at a landfill. The removed material consists of rocks, sand, eggshells, plastic trash, cloth, bones, etc.



Operations received the monthly delivery of ferric chloride to an on-site bulk storage tank. Ferric chloride is used to enhance settling in the primary treatment process and inhibit siloxanes from entering digester gas. Siloxanes, silicon-derived chemical compounds, are present in cleaning products such as shampoos, detergents, deodorants, toothpaste and cosmetics. Without the addition of ferric, the siloxanes present in biogas produced during anaerobic digestion damage the cogeneration equipment.



## Water

Projects, projects, projects – we continue to make progress on projects underway and on new programs as well:

### Newell Creek Dam Project Update

- WD Staff held a kick-off meeting with State Water Board staff to discuss compliance with our SRF loan. Staff also submitted our first two reimbursement requests, which totaled over 4,000 pages of documentation.
- The contractor is working on the soil nail wall for the tunnel portal of the project. Division of Safety of Dams (DSOD) was on-site for some of the activities this week.

- Dredging continues, with the depth to Intake No. 1 having been reached, and deeper intakes 2 and 3 likely to be completed next week.
- Lake turn-over appears to have had a positive impact on the project in terms of turbidity, reducing it by 50%. Turbidity inside the silt curtain is also proving much lower than expected.

### **Completion of the U-5 tank project**

Granite Construction completed repaving on El Refugio. WD staff worked closely with the contractor, neighbors and operations to ensure drainage and accessibility issues were appropriately addressed. The final steps are the permit mitigation work and, tangentially related, dealing with horse manure neighbors have been storing at the U-5 tank gate.

### **Coast Pump Station Pipeline Replacement Project**

- The microtunneling equipment has been demobilized.
- The 24" water main pipe has been installed in the 42" casing pipe under the river and will be pressure tested Thursday.
- After passing the pressure test, risers will be installed.
- The project team is setting up a lessons learned workshop for the project, the first we've had. We're eager to learn some lessons and apply them to future projects.

### **Enhanced post-fire water quality monitoring**

Production brought the San Lorenzo River back into service this week for the first time since the rains a few weeks ago. The river was taken offline before the rain, and it stayed that way as turbidity and color were elevated after the first flush storm event. We're still waiting on the bulk of the results from the enhanced monitoring that we set up to evaluate the fire's impact on water quality. But some initial results do suggest that the fire is having an influence.
