Planning and Community Development

433 Ocean Street. The Planning and Community Development department recently received a Pre-application to redevelop a property on the southwest corner of Ocean Street and Soquel Avenue which currently contains a vacant service station. The applicants are proposing a 36,990 square foot, three-story hotel with 50 guest rooms. Amenities include underground parking and a rooftop pool and bar area. A Community Meeting will be required pursuant to the City's Community Outreach Policy for Planning Projects and the feedback provided may contribute to alterations in the project design. There are no formal actions that are taken to approve or deny a project that's been submitted for Pre-application review, rather the process results in feedback from the City and the community. Ryan Bane is the planner working on the application.



Public Works

Traffic Engineering

We are excited to announce that we have been awarded a \$9 million Active Transportation Program grant from Caltrans for construction of Rail Trail Segment 7/Phase II! The project will create .8 miles of paved, multi-use path from Bay and California streets to Pacific Avenue.

The project furthers implementation of the largest active transportation project in Santa Cruz County, offering an important path towards long term mode shift. It connects to the recently completed Coastal Rail Trail Segment 7/Phase I, which serves over 600 active transportation users per day as measured by automated counter in 2021. [Learn more.](#)



We released our [2018 and 2019 Annual Traffic Safety Reports](#). These reviews focus on crash data of reported traffic collisions that resulted in injury or fatality for the years ending Dec. 31, 2018 and Dec. 31, 2019. The data shows some promising trends and provides a guide for future engineering and enforcement effort improvements. Highlights of the reports include:

- Injury collisions involving pedestrians (25) decreased by 60 percent.
- Injury collisions involving motorcycles (7) decreased by 27 percent from 2018 to 2019.
- The number of felony hit-and-run collisions (4) decreased by 24 percent from 2018 to 2019.
- Alcohol-involved collisions (10) decreased by 35 percent.
- Total injury collisions (16) are down 9 percent and fatal collisions (1) are down 50 percent from 2018 to 2019.
- After a significant decrease from 2017 to 2018, bicycle injury collisions (17) increased by 36 percent from 2018 to 2019. That said, bicycle injury collisions have been trending downward over the past 10 years, with a decrease of 40 percent since 2015.

Our Water Quality lab staff has had a tough year. In addition to all the protective measures that had to be taken to keep this critical team safe and healthy through the pandemic, and the added workload monitoring possible water quality impacts from the CZU fire, their state-certified water quality laboratory suffered a significant water-main break last summer that caused them to temporarily relocate while repairs were made. (And no, the irony of the main break wasn't lost on us.) Also during that time, their long-time section manager retired and they were down staff members.

So we're glad to report that the team is finally back in the lab. Lindsay Nuen was promoted to section manager, and they are close to being fully staffed. Like many Water Department employees, these team members are unsung heroes who ensure your drinking water is safe, clean, and tasty.

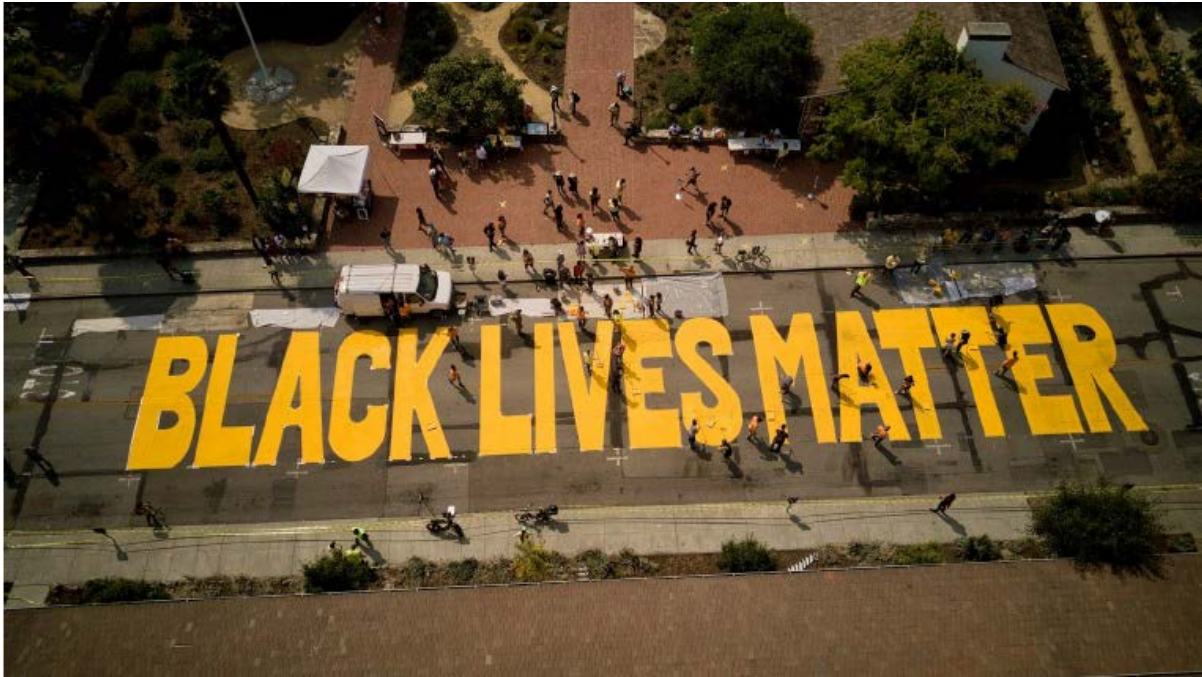
CARD PILOT GRANT PROGRAM ACCEPTING LETTERS OF INTENT

ARTS COMMISSION APPROVES SUPPORT FOR BLACK LIVES MATTER MURAL CELEBRATION 2021



The BLM Mural organizers originally envisioned that each year there would be an annual event to engage the community in maintenance of the mural to affirm the community commitment to racial equality. In 2021, they joined the City Juneteenth Celebration Planning Committee. That group made the decision to commemorate Juneteenth 2021 virtually due to COVID restrictions on public gathering. The BLM Mural organizers will, however, host a day of mural restoration with limited participation and with invited speakers. The Arts Commission approved funding for expenses related to the mural restoration, the staging and compensation for invited speakers, and professional documentation by videographers. 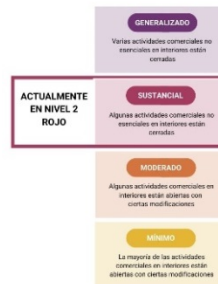
- Personal Care Services
- All Retail with max 50% capacity
- Restaurants with max 25% capacity or 100 people, whichever is fewer
- Gyms and Fitness Centers with max 10% capacity
- Museums, Zoos, and Aquariums with indoor activities with max 25% capacity
- Movie Theaters with max 25% capacity or 100 people, whichever is fewer
- Shopping Centers (Malls, Destination Centers, Swap Meets) with:
 - Max 50% capacity
 - Closed common areas
 - Reduced capacity food courts (see restaurants)
- Hotels and Lodging with Fitness centers with 10% max capacity
- Places of Worship with max 25% capacity or 100 people, whichever is fewer
