

# City Manager's Weekly Update

June 18, 2021

## Water

As the temperature has increased this week, so has water use. In fact we're predicting today may be the highest use so far this year, at over 9 million gallons. That's high use for Santa Cruz now, but was pretty routine back in the days before 2014 rationing.

Related to that, one of the questions we've been hearing from customers lately is "why are the allocations for a single family residence half of what they were during rationing in 2014-2015?" It's a good question. The short answer is because the community's water use never rebounded after the last drought; customer use characteristics used to develop the 2009 Water Shortage Contingency Plan, which was the basis for 2014-2015 allocations, was based on how customers used water in 2002-2004. The updated allocations being used today are from 2016 – 2018 use. Customer demand is now so much lower than it has been historically, that average water use for single family customers is now just 6 ccf per month. Overall demand never rebounded from the restricted levels achieved between 2014 and 2015. We keep a running list of [frequently asked questions](#) about the Stage 1 Warning on our website – it's updated weekly.

The good work that our Water Resources team does monitoring special status fish species was highlighted in a [front-page article](#) in yesterday's Sentinel. It was nice to see Chris Berry and his team recognized for their efforts year after year to try to protect coho salmon and steelhead trout.

Last, we're expecting a big turnout at Loch Lomond Recreation Area for Father's Day. It's already been a busy summer, but with continued reports of good fishing, it's bound to be the spot where many dads choose to spend their day!

### **Governor Newsom Signs Executive Order Aligning OSHA Regulations With CDPH Guidelines**

Following the vote by the Occupational Safety and Health Standards Board to adopt revised COVID-19 Prevention Emergency Temporary Standards that reflect the state's latest COVID-19 public health order, Governor Gavin Newsom today signed an executive order enabling the revisions to take effect without the normal 10-day review period by the Office of Administrative Law – providing clarity and consistency for employers and employees as California fully reopens its economy.

Among other updates, Cal/OSHA's revisions align with the [latest](#) guidance from the California Department of Public Health – based on guidelines issued by the Centers for Disease Control and Prevention – on face coverings and eliminate physical distancing requirements, except for certain employees during outbreaks. Unless they show symptoms, fully vaccinated employees do not need to be offered testing or be excluded from work after close contact with a COVID-19-positive person.

Ensuring workplaces throughout the state have consistent guidance as California officially moves [Beyond the Blueprint](#), the Governor's order waives the 10-day review process by the Office of Administrative Law. The emergency regulations will take effect upon their filing with the Secretary of State. With over 40 million vaccines administered and amongst the lowest case rates and transmission rates in the nation, the state fully reopened on June 15, eliminating pandemic-related restrictions that have been in place over the past year.

Initially implemented last November, the COVID-19 Emergency Temporary Standards remain an important component of the state's ongoing response, providing balanced worker protections that support California's continued progress in recovering from the pandemic.

## **Homelessness Response**

Caltrans will be noticing the “Hell’s Trail” area behind the intersections of Highways 1 and 9 this weekend and closure will occur on Monday, June 21. The agency estimates that there are 30-45 individuals camping in this area.

Conversations are continuing with the County regarding the demobilization of emergency shelters within the City and County as FEMA funding is expected to wind down in September. Director Lee Butler will provide an update on these efforts and potential impacts to homelessness response within the City during his presentation at the Council meeting on Tuesday.

### **San Lorenzo Park**

City attorneys and staff met and conferred with plaintiffs in the Santa Cruz Homeless Union vs. The City of Santa Cruz case this week. The City heard from the plaintiffs on some concerns about specific elements of operations at the site, such as the need for additional shade, the location of portable toilets, and more frequent refuse pickup. City staff are working to evaluate the full list of requests and respond with solutions where feasible.

Two individuals were evicted from the Benchlands camp in San Lorenzo Park following many continued warnings for violating community standards. Per the terms of the eviction, these individuals were issued a “stay away” order that will remain in place for 60 days.
