# Police

### National Police Women Day In Tune with SCPD Recruitment Effort

SCPD celebrated National Police Woman Day on Sept. 12. The day acknowledges and celebrates the contribution of female police officers who enforce law and order around the country. SCPD is proud of the amazing women wearing the badge to serve and protect the City of Santa Cruz. We thank all the women in our ranks for their dedication to protect, serve and inspire.

Today about 10 percent of the police force in the United States is made up of women. Santa Cruz Police Department aims to increase female representation in our ranks by encouraging more women to join the service. SCPD encourages more women to pursue a career in law enforcement through ride-alongs, FAQ sessions, one-on-one meetings with our women police officers, mentorships, and career fairs. 

# **Public Works**

### **Engineering**

A group of 132 volunteers bagged 162 lb. of trash and 18 lb. of recycling at Cowell and Main beaches and three river levee sites Saturday! The City co-sponsored this Santa Cruz effort for Annual Coastal Cleanup Day led by Save Our Shores.



### **Operations**

The annual San Lorenzo River vegetation management for flood control will start the week of September 27 and is expected to take approximately 4-to-6 weeks to complete. The Army Corps of Engineers requires this project before the rainy season starts and will follow the environmental guidelines of the California Department of Fish and Wildlife. The work will occur in sections from Hwy 1 to the Water Street Bridge, Water Street to Soquel, Soquel to Laurel, and Laurel to Riverside. Read more.



#### **Streets**

Streets crews have been conducting citywide road repair and driveway repair on Church Street, where a portion of the sidewalk was damaged due to fire trucks entering the driveway. Contractors conducted vegetation removal in Branciforte channel and Arana Gulch drainage channel in preparation for the winter season.

#### **Facilities**

Crews assisted in investigating access to water to the Armory and obtained a quote for a water line repair.

### Fleet/Garage

The majority of FY22 vehicle orders with Enterprise Fleet Management have been placed; we are only waiting on specs and pricing for a few models.

## Planning and Community Development

#### 818 Pacific Avenue/Pacific Station South

On September 20, 2021, the Building Division of the Planning and Community Development Department received a building permit application to construct a 100 percent affordable, mixed-use development known as "Pacific Station South." The project includes the demolition of three commercial buildings and the construction of a seven-story building with



ground-floor commercial and residential amenity space, a second-floor medical office, and five floors of residential apartments above. The project utilized State Bills AB 1763 and AB 2162 to allow the building to project three additional stories or 33 feet above the maximum permitted height, eliminate all on-site parking requirements, and streamline the permitting process. With these two state bills, the project only required approval of a Coastal Permit, which the Zoning Administrator approved on Dec. 2,

2020. The project was approved with 85 units; however, changes in funding regulations required an increase in the number of two- and three-bedrooms units, which resulted in an overall reduction to 70 units but an increase in bedroom count. The change in unit types provides more family-style housing, which better integrates with the medical clinic use within the building. Construction is expected to begin in the Spring of 2022.

# Water

This week we're taking a big step forward with yet another major project. We're finalizing the sole source purchasing agreement for our Meter Replacement Project. This agreement achieves competitive pricing on the meters, radios, and advanced metering information (AMI) data services that will complete a wholesale replacement of our metering system.

Like much of Santa Cruz's critical water infrastructure, our meters have passed their useful life expectancy. This negatively affects the water system and our customers. It affects our water system because broken meters cause us to lose water due to leaks and other uses that aren't recorded and identified. It affects our bottom line because broken meters don't record use (and associated charges) accurately, and it affects our customers for both of the aforementioned reasons. In addition, a broad replacement of old meters with new meters will provide our customers with the tools they've been asking for: a way to more accurately track their water use (especially during restrictions) and a way to manage their water costs.

We've been replacing old and broken meters on a piece-meal basis. Being able to purchase and replace them on a wholesale basis reduces the costs significantly.



Last summer we hired temporary staff to inventory the condition of every meter in our system. With over 25,000 meters, the job took several weeks to complete.

# **Parks and Recreation**


### **Celebrating the Reopening and Rehab of Central Park!**



# Citywide Initiatives

### San Lorenzo River Coordination Team Quarterly Report

The City and community groups continue to maintain the land adjacent to the river. The City provides trash service along the levee nearly every day of the week and the Fire Department is also conducting weekly fire inspections of the Benchlands encampment at San Lorenzo Park.

The Benchlands Encampment Stewardship Team continues to meet weekly to build community relationships and steward the river and its adjacent open space. The Estuary Project, another community group, recently planted 12 Buckeye trees with the City and a Girl Scouts Brownie troop, earning troopers their first service badge.

Santa Cruz County, based on recent sampling (August 24 and 26), has permanently closed the San Lorenzo River mouth to the public due to impaired water quality. The City is evaluating sources of water quality impairment and ways to improve the situation.

Targeting completion by July 2023, the City is continuing progress on certification of the San Lorenzo River flood control levee in order to retain discounted National Flood Insurance for those properties within the flood zone.

The City supported a storm drain mural project at Poet's Park in the Beach Flats neighborhood, led by the Coastal Watershed Council and artist Irene O'Connell.

The City will be conducting vegetation management of the dry riverbanks of the San Lorenzo River during September. Notifications to community members are taking place through various channels.

### **Homelessness Response**

#### **Programming**

The City and the County are in conversation about continued operations at the Armory beyond the previously announced closure date, as well as for the siting of the first safe sleeping site. Program model options are being reviewed, and communications with potential operational organizations are underway. There will be more to report on the outcomes of the City and County's collaborative efforts before the end of October.

#### San Lorenzo River Vegetation Management

Over the next two months, the federally-required annual SLR vegetation management (for flood reduction) will be underway. Vacate notices have gone up for the project's first phase (Hwy 1 to Water St.). Benchlands Steward Staff have accompanied enforcement to connect campers to sites in the Benchlands and connect campers to County services. Phase 2 of the project (Water St. to Soquel) will include the clearing of debris and closure of the encampment adjacent to the Soquel bridge to allow for the staging of equipment required to complete the work. Phase 2 is expected to begin in approximately two weeks, and osutreach has already begun to these campers. The closure is projected for the first week in October.
