



City Manager's Weekly Update

City of Santa Cruz

January 16, 2023



Every day, the City's dedicated outreach workers bring compassion and kindness to their interactions with clients. They know many unhoused individuals by name, understand their backstories, and encourage people to accept services who otherwise would not. In many cases, these individuals had not accepted services from others. Over the past two weeks – and as the winter rains continue – the outreach team has been in the field providing access to services and shelter and making connections with people. In the past year, this team is credited with supporting at least 250 campers toward more stable housing.

City Shelter Spotlight

The 1220 River Street Transitional Community Camp opened in January of 2022. This low-barrier, tent-based program is designed to offer participants a transitional location to stabilize. With the support of City staff case managers and their fellow participants, guests build such individual service plans as obtaining

vital documents, getting jobs, accessing support services, and, ultimately, finding more stable housing. All program participants receive case management coordination and connection to services. Since its inception, 30% of guests have moved into more stable shelter or long-term housing.

Long Term Housing Secured

A couple who had been part of the 1220 River Street Transitional Community Camp recently found permanent housing with assistance from our City outreach staff and County support programs.

The 1220 River Street Community Camp provided the pathway to stable housing. The couple moved out of their car into the supportive environment at 1220 River and ultimately, into permanent housing. During their time at 1220 River, the couple was able to look for housing, access health care, seek services, and maintain full-time employment. The community provided

the breathing room they needed to begin their transition from living without a home to long-term housing.

Ongoing Outreach

The City will continue to monitor and address public health and safety issues that may arise related to other encampments. Priority areas for this week include the Clock Tower, Scope Park, the Post Office, Civic Center, City Hall, and Lower Pogonip. The City Outreach team has been on-site multiple times, connecting people to alternative shelter and services.

CA Venues Grant

CalOSBA's California Venues Grant Program Opens Round of Funding Economic Development

Last month, the California Office of the Small Business Advocate (CalOSBA) announced a second round of nearly \$45 million in new funding for the California Venues Grant Program. The program provides grants to eligible independent live event venues with revenues impacted by COVID-19 in 2020.

The first round of the California Venues Grant Program distributed more than \$111.5 million in the fall of 2021 to nearly 830 eligible independent live events venues, including more than 150 women-owned businesses and 587 small businesses in low-income areas.

Round 2 Funding Information

- Application Window – December 19, 2022, through January 31, 2023
- Eligible applicants – Independent live event venues affected by COVID-19
- Eligible grant award – Grants will be the amount lesser of either two hundred fifty thousand dollars (\$250,000) or 20% of the applicant's gross earned revenue in California for the 2019 taxable year.
- Application process – If applicants previously applied for the California Small Business COVID-19 Relief Grant Program, those applicants must complete a new application to be eligible for this program.
