

## Environmental Compliance Public Works Division



This report describes the national effort for a cost-effective plan for production of high quality potable water from wastewater by scientifically informed planning of wastewater sources. ## Community Meeting on Peace Village Held to Gather Public Input



On February 8th, the applicant for the proposed 40-unit apartment building at 900 High Street held a virtual community meeting to present the project to the public and hear feedback consistent with the Community Outreach Policy. Approximately 96 community members attended. Participants expressed both support for and concerns with the project. Input topics included traffic, parking, density, pedestrian safety, development height, bicycle parking, open space, refuse management, construction noise, affordable housing, and wildlife habitat. The application is currently incomplete. Once the application is complete, the project will require a public hearing before the Zoning Administrator. Clara Stanger is the planner working on the project.

## Public Input Gathered at Community Meeting on Ocean Street Project

On February 9th, the applicant for the new project at 908 Ocean Street held a hybrid community meeting virtually and in person to present to the public and hear feedback consistent with the Community Outreach Policy. The proposed development is a mixed-use project with 354 dwellings and ground floor commercial space along Ocean Street. Approximately 39 community members attended. Feedback topics include state laws on parking; standards affecting project review; construction noise; building height; shade studies; open space; rental prices; neighborhood residential permit parking; design consistency with the Ocean Street Area Plan; traffic; local labor for construction; affordable units; provisions for displaced tenants; pedestrian and cyclist safety; project timing; electrical infrastructure; and design considerations to limit loitering and crime. A preliminary application review was completed for the project and a formal development application is expected to be submitted in the coming months. Once the formal application is complete and CEQA review is completed, the project will require a public hearing for approval by the Planning Commission.
